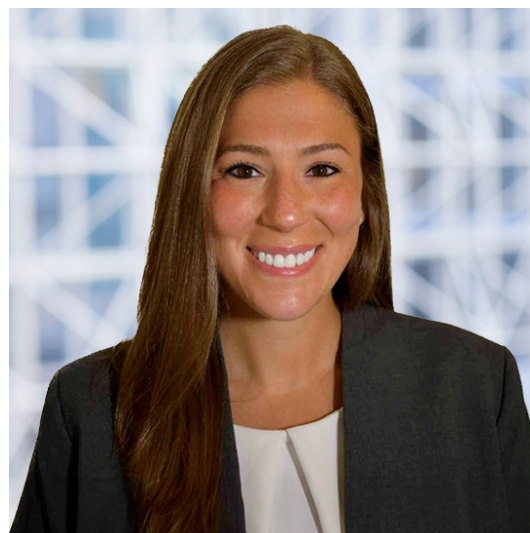
Biography
